



Timeline Of the Virgin Islands History

LEGISLATIVE MURAL

On the walls of the Earle B. Ottley Legislative Hall is a historical mural entitled "Chapters in Our Virgin Islands History." The 4.5 ft. by 24 ft. acrylic painting was created by St. Croix native El'Roy Simmonds in 2000 after thorough research of Virgin Islands history at home and in Denmark.

PANEL 1 – CHAPTER 1 PRE-COLUMBIAN INHABITANTS

This chapter reflects how and where the native Caribs lived and in the distance the ships symbolize Columbus' arrival at Salt River, St. Croix on November 13, 1493.

PANEL 2 – CHAPTER 2 EUROPEAN OCCUPATION IN THE VIRGIN ISLANDS

The various flags in this chapter are arranged based on the order of occupants and goes as follows:

- #1 Spain
- #2 Holland (Dutch)
- #3 Knights of Malta
- #4 France
- #5 England
- #6 Denmark
- #7 United States

PANEL 3 – CHAPTER 3 THE TRIANGLE SLAVE TRADE

The top of the painting depicts Fort Christianborg located in Ghana where enslaved African were housed before being transported abroad, and the bottom left displays Fort Frederik on St. Thomas, the sugar mill at Annasberg on St. John and the bell tower in Fort Frederik on St. Croix.

The cracked design (triangle) across the painting illustrates the Danish Triangle Slave Trade and inside the triangle reveals the faces of those who endured torture, and separation of families, country and history of African people. Top left displays Fort Frederik on St. Thomas, the sugar mill at Annaberg on St. John and the bell tower in Fort Frederik on St. Croix. The cracked design (triangle) across the painting illustrates the Danish Triangle Slave Trade and inside the triangle reveals the faces of those who endured torture, and separation of families, country and history of African people.

PANEL 4 – CHAPTER 4 FREEDOM FIGHTERS

The upper portion depicts the Aminas with the burning of the estates signifying their victory in their struggle for freedom on St. John in 1733. In the background there is a hand holding a flag depicting the conquerors from the nation of Ghana and their decision to "go home to their Maker" rather than endure the inhumane treatment by their colonizers. The middle portion of the painting depicts an enslaved African blowing a conchs Shell to communicate to others that "the time is now" and at the center a scroll held by General Moses "Buddhoe" Gottlieb declaring "All unfree in the Danish West Indies are from today free – July 3, 1848." The words on the scroll were written by Governor Peter von Scholten, who is to the right of 'Buddhoe' along with Ana Hegaard. In the lower section of the painting, Mary "Queen Mary" Thomas, Queen Agnes, Queen Mathilda (also known as Bottom Belly) and Axeline "Black Amazon" Solomon are portrayed during the "Fire Burn" of 1878 on St. Croix.

PANEL 5 – CHAPTER 5 TRANSFER

This page shows the Danish flag, the Donneborg with the right end of the flag folding indicating that it is losing wind in the process of being lowered. The middle flag is the Virgin Islands flag which represents the people and the Stars & Stripes above representing the new mother country, the United States of America.

PANEL 6 – CHAPTER 6 GROWTH, DEVELOPMENT AND PROGRESS

TOURISM

The top portion of this page depicts one of the many cruise ships that dock on a daily basis and reflect of the many Danish ships that have entered the port for hundreds of years.

AGRICULTURE & INDUSTRY

The left portion, in the foreground, shows a sugar mill on St. Croix when sugar was "king" and today St. Croix boasts the second largest oil refinery in the Western Hemisphere, namely HOVENSA.

EDUCATION

In the right hand portion of this page depicts a design of a Danish public school and the University of the Virgin Islands.

TRANSPORTATION

The lower portion reflects on the donkey cart as a means of transporting people and heavy loads, and in the background the VITRAN bus illustrates the progress made through mechanical evolution.

PRIDE

The seal placed in the center of the picture is confirming the development, growth and progress of the people of the Virgin Islands.

The architectural background (from top to bottom) features the façade of Government House in Christiansted, St. Croix; the façade of the Capitol Building in Charlotte Amalie, St. Thomas and the façade of the White House in Washington, D.C.

PANEL 8 – CHAPTER 8 OUR PEOPLE

The last chapter indentifies a few of the Virgin Islanders who have made marked progress and achieved fame in various occupations. From top left going clockwise is: National Basketball Association superstar Tim Duncan; World Boxing Champion and boxing hall of famer Julian Jackson; Bradley Christian known for his love and promotion of our national music and dance, Quelbe & Quadrille; Stanley and the Ten Sleepless Knights; Caroline Adams, the first black female pilot in the VI National Guard; and Emilio "Milo" Francis, leader and founder of the world renowned calypso band, Milo and the Kings, now posthumously renamed "Milo's Kings" in honor of its founder.

U.S. Virgin Islands Legislative History

The beginning of the Legislature can be traced back to the passage of the Colonial Law of 1852. This law, the first "constitution" of the Islands. provided for the establishment of a unified Colonial Assembly and for a Governor as the chief executive. or to be more accurate, as a Vice Regent of the King of Denmark. The governor, as the king's direct representative, had the power to issue ordinances which had the force of law. In addition, he had the power to dissolve the Assembly with the provision that this not be done more than twice in two years and that a new election be held within two months of the dissolution. The Colonial Assembly, which served all three Islands, was basically limited to an advisory role. It could only make recommendations which could be accepted or rejected by the governor. In addition, the King still reserved the final authority to reject or amend any law made in the colony.

The Colonial Assembly, in addition to its lack of decision-making power, had serious flaws. It was forced to attempt to combine two incompatible economic systems into one political system. St. Thomas, with a commercially based economy, had totally different requirements from St. Croix, which had an agrarian one. Because St. Croix had a larger delegation to the Assembly than either of the other two Islands, many recommendations were passed which were unfavorable to St. Thomas. To make matters

worse for the St. Thomian delegates, meetings were held on St. Croix. Eventually, because of a combination of transportation difficulties and hostilities, St. Thomian delegates ceased to attend meetings and consequently, none were conducted between 1856 and 1859. Needless to say, this legislative system soon fell apart, and eleven years after its inception, was superseded by the Colonial Law of 1863.

The Colonial Law of 1863 changed the system of government by dividing the islands into two Municipalities which were St. Thomas - St. John and St. Croix. Each Municipality was served by a Colonial Council, both of which could combine as an Assembly on the call of the governor or both Councils. The Councils had slightly greater powers than their predecessors and they had some measure of financial control that is usually inherent in legislative bodies as we know them. However, many limitations on the powers remained firmly in the hands of the King and his direct representative, the governor. All final decisions rested with the King. In addition, the King appointed four members to the St. Thomas -St. John Council and five to the St. Croix Council. An additional handicap was the amount of deliberation necessary to adopt any measure. Before the Council adopted any measure, it was subject to revision three times. The first revision period permitted general discussion, in the

second the governor or the council could make amendments, and in the third, only the governor could make amendments. As aforementioned, any measure was still subject to the approval of the King in order to become law.

The Colonial Law of 1863, besides dictating the structure of government, also dealt with the important matter of enfranchisement. It was the opinion of the lawmakers at the time that landowners and other people of means were those that truly had a stake in the society and therefore should be the ones represented at the polls. As a result, the strict property and income qualifications stipulated by the Colonial Law of 1863 were such that only 5.5 percent of the population was able to vote. This caused a double disadvantage for the average citizen who saw not only a Colonial Council that was practically powerless, but one in which he was unrepresented. To put it simply, the average or "grass roots" people had no voice whatsoever in the running of the government.

The Colonial Law of 1906 was basically an amendment to the Colonial Law of 1863. Of its provisions, the most noteworthy is one which states that before any ordinance is adopted, the opinion of the Assembly must be solicited. While this further insured that the voice of the Councils would be heard, it still gave them no power to enact or influence any legislation.

This law of 1906 was the last "constitutional" document handed down by the Danes and it reflected the fact that to the very end, the Danish government felt that although the natives should be free to express their opinion, the decision making functions must rest with the government of the "mother country." To the end of Danish rule, Virgin Islanders had little self-government. The lack of self-government, along with dire economic straits for the islands led to the widespread native approval of the sale of the islands in 1916 and their subsequent transfer in 1917. The natives assumed, that along with the rights of American citizenship, they would also receive a greater measure of self-government. As things turned out, they got neither.

When the United States took over the islands, it was a hasty and forced move for which the sole purpose was to prevent the Germans from taking them and thus to improve strategic defense of the Panama Canal. Therefore, the Islands, unlike the Louisiana Purchase or many other territories, were not acquired for purposes of expansion, but simply as a military possession. As a result, the natives were not granted citizenship and the administration of the islands was delegated to the Department of the Navy. The Navy, never known for being socio-politically gifted, decided to leave what seemed to be well enough alone and thus, with the obvious exception of having a Naval officer take the post of governor,

there was no significant change in the structure of government. Under the Administration of the Navy, significant progress was made in the more material aspects of life. New roads and hospitals were built, and efforts were made to improve sanitation and education in the islands. However, the years of the "Naval Regime" from 1917-1931 were long, bitter years for those who sought greater self-rule in the Virgin Islands. The training and temperament of the average ranking Naval officer was not at all suited to the running of a popular government for a peaceful group of people. Therefore, according to the natives, the majority of Naval governors conducted island affairs in much the same manner as they would have run a battleship. To make matters worse, the Federal Administration largely lost interest in the islands after World War I as they had served their original purpose. As a result, there was little or no effort on the part of the administration to oversee the affairs of the islands and the governor was thus left quite free from outside interference. This combination of federal neglect, carried over Danish laws, and Naval temperament conspired to effectively stymie any efforts at self-government.

As the saying goes, the years of the "Naval Regime" bred many seeds of discontent and produced such "radicals" as Rothschild Francis and D. Hamilton Jackson as well as others who fought for greater civil liberties and the removal of the Naval

administration. In 1927 United States citizenship was granted to Virgin Islanders. Finally, in 1931, with the help of the American Civil Liberties Union (ACLU), the native leaders had stirred up enough publicity and outrage that President Herbert Hoover signed an order which provided for the transfer of the administration of the islands from the Navy Department to the Department of the Interior. While the yoke of the Navy had been lifted, no structural changes were made in the government and active leaders continued to press for change.

On June 22, 1936 the United States Congress passed the Organic Act of 1936. Under the provisions of this Act, a true system of civil government was set forth for the Islands. The two Colonial Councils, now Municipal Councils with the exclusion of the appointed members, remained, and could still combine to form a Legislative Assembly, but they were given legislative power to pass laws and to override the governor's veto by two thirds vote, although in this event, final veto power went to the President of the United States. The Legislative Assembly, which could convene upon passage of resolutions by both Councils or on the call of the governor, had the authority to enact legislation for the entire Virgin Islands. To be eligible for membership in a Municipal Council, a candidate had to be at least twenty-five years of age, a qualified voter in the municipality in which he sought election, and be a resident of that municipality

for not less than three years preceding the date of election.

The Organic Act of 1936 was a major sign of victory for native Virgin Islanders who wanted a greater measure of self-government. Of this act, the greatest features included the granting of universal suffrage and permanent removal of property and income qualifications for voting. This took political control of the Islands from the upper class and "landed gentry" and placed it squarely in the hands of the thousands of working and lower class citizens in the Virgin Islands. Thus, the face of the legislative branch was also changed. Conservative legislators preferring the status quo were replaced by more liberal, sometimes even radical ones who were more dedicated to bringing about social and economic changes and better working conditions for the working man or the "grass root."

Despite the apparent victories, however, there were still items left to be desired in the new governmental system. Although Councils were empowered to enact legislation and override the governor's veto, the Congress of the United States still reserved the power to annul any and all legislation enacted by the Virgin Islands government. The President of the United States retained final veto power in the case of a legislative override of the governor's veto. In addition, the Legislative Assembly, the body that passed laws for the entire territory, was the representative of unified government. It did not

meet with the frequency that would have been desirable and was only empowered to act on bills proposed by the governor or by both the separate Councils. In other words, the Legislative Assembly was not capable of independent action. It can be said therefore, that there was still no viable working instrument to enact legislation for the entire Virgin Islands and that a unified system of government was still woefully lacking. By this point, it was more than high time that one was put into effect. In 1954, this unified legislative system was put into effect when the United States Congress passed the Revised Organic Act of 1954. Among other things, this Act created a unicameral body called the Legislature of the Virgin Islands in which all legislative power was vested. For the first time since 1863, the government of the Virgin Islands was fused into one entity. A relatively equal balance of power between the executive and legislative branches was finally attained. In addition, equal representation from St. Thomas and St. Croix was achieved.

The Legislature created by The Unicameral Legislature created by the aforementioned Act, consisted consisted of eleven members: three from the District of St. Croix; three from the District of St. Thomas; one from the District of St. John; and four at-Large, serving all three islands.

The at-Large concept was utilized solely for the purpose of embodying the unified interest and to reduce

inter-island deadlocks.

In 1966 the Legislature underwent further change when the United States Congress and the Virgin Islands Legislature passed a resolution. The number of seats was increased from 11 to 15 and the distribution changed to the following: seven from the District of St. Thomas - St. John: seven from the District of St. Croix: and one At-Large who must be a resident of St. John. With that move, the Legislature of the Virgin Islands had finally evolved into its present form. It is now a body with the rights and powers enjoyed by most state legislatures of the Union. With the century-long development of the legislative branch from Colonial Assembly to Virgin Islands Legislature, we see an important part of a people's struggle for self-determination and self-government.

The Legislature is one of three coequal branches of the Government of the Virgin Islands of the United States, with its own powers delegated by the Revised Organic Act of 1954, passed by the U.S. Congress, which established our local government. The other two branches are the Executive Branch, which is headed by the Governor and is responsible for administering the laws passed by the Legislature; and the Courts, usually called the Judiciary, which interprets the laws passed.

Office of the Executive Director

The Executive Director is central to the administration and functioning of everyday legislative business. The Director is responsible for the daily administration of the legislative offices on all three islands, and is assisted on St. Croix by a full time Assistant Executive Director. All bills, legislation initiated by the Governor, zoning change petitions, commendatory resolutions, and formal correspondence pass through the Office of the Executive Director before reaching the floor of the Senate. Acting as clerk on the floor, the Executive Director staff reads all bills, resolutions, and correspondence, and conducts all votes put to a roll call. Additionally, the Executive Director is responsible for the printing and distribution of bills, acts, journals and other official documents; the preservation of legislative records; and the supervision of all employees who may be assigned to his office by the President of the Senate.

Post Audit Division

The Division of Post Audit is attached to the Legislative Standing Committee on Finance. The Post Auditor monitors the financial affairs and transactions of every department or agency of the executive, legislative, and judicial branches of government. Post audits are made to discover evidence of unauthorized, illegal, irregular, or improper handling or expenditure of funds

Office of Legal Counsel

This office is responsible for bill drafting and research for the members of the Legislature. The Legal Counsel insures that the language of bills that are introduced is legally correct and

consistent with the Virgin Islands Code. In addition, the Legal Counsel advises the Senate on parliamentary procedure and acts as the legal arm of the Legislature on matters of litigation. The Chief Legal Counsel reports directly to the President of the Legislature.

Division of Human Resources

Provides services to all senators and staff.

Division of Business and Financial Management

The Business Office is responsible for computing payroll, per diem, and expense reimbursements for each Senator and employee. The office acts as a purchasing clearing house for all items approved by the Executive Director or the Senate President, and performs all legislative bookkeeping and accounting functions as well as compiling and maintaining all fiscal records of the Legislature.

Division of Management Information Systems (MIS)

Provides information technology assistance to all senators and staff.

Office of Media Services

Media Services was established to disseminate accurate and timely reports on legislative activities through print, radio and the Legislatures' own television system; LEGVI TV. The public is served by the daily press releases and reports on the legislative activities for that day, and the weekly up-dates and periodic analysis on controversial or complex bills. The Office also provides an update on the disposition of bills in the various committees.

Legislative Archives

Legislative Archives, headed by a Chief Archivist, is responsible for the effective organizing of documents, and for storing records, and all other legislative reference materials. In addition, Archives works in concert with the Legislative Library, which is under the jurisdiction of the Legal Counsel's Office, giving that office maximum research capability.

Journal Section

The Journal Section is responsible for typing, printing and distributing all legislative bills and journals. The Journal Section maintains a bill register which records each bill, along with its sponsors, committee assignments, and dates of introduction, report to the floor, and adoption, veto, and subsequent action. At the end of each year, the Journal Section prepares a complete resume on each piece of legislation introduced, which is then submitted to the Lieutenant Governor's Office for printing into the Session Laws and subsequent codification.

Legislative Reporters

The Chief Recording Secretary is the Chief Recording officer of the Legislature. The duties of the Recording to record and transcribe verbatim each meeting of the Legislature, and to provide a copy of the verbatim transcript to each member of the Legislature, the Executive Director, and the Chief Counsel upon request. They also record and transcribe verbatim any meeting of a Committee of the Legislature when directed to do so by the President or his or her designee;



Sergeant-at-Arms

The duties of the Sergeant-at-Arms are as follows:

- (a) to attend the Legislature during all of its sittings and to execute the commands of the Legislature, together with all such processes issued by authority thereof as shall be directed to him by the President;
- (b) to enforce strictly the Rules as they relate to order and decorum in the Legislative Chambers;
- (c) if directed, to establish a quorum at each meeting of the Legislature as provided in Section 205 (c) of the Rules; and
- (d) to perform such other duties as may be prescribed by the Executive Director, and to supervise such employees as may be assigned by the President to assist with those duties.

The Sergeant-at-Arms is authorized to arrest for contempt all persons in the Gallery found in loud conversation or otherwise disturbing the proceedings of the Legislature.

Facilities Management

The duties of the Maintenance Division are as follows:

- (a) to provide a maintenance, custodial and construction staff of persons qualified and trained in building repairs, maintenance and construction;
- (b) to prepare estimates of materials and labor costs for repairs and construction work to be done on offices and buildings of the Legislature; (c) to inspect work performed in the various offices of the Legislature by private contractors in plumbing, painting, repairs, electrical and other work; and;


(d) to prepare reports to the Executive Director on the condition of the various offices of the legislature in St. Thomas, St. Croix and St. John





This chart indicates that as a result of the purchases of newer more gas efficient vehicle model for the fleet the Legislature was able to save thousands of dollars on fuel even though fuel cost in the territory has steadily been fluctuating.

Cellphone services expenses:

This chart indicates that as of 2013 with the implementation of the 30th Legislature's SOP -(Standard Operating Procedures), the Legislature does not provide cell phone devices to Senators nor Staff, and does not compensate or reimburse Senators nor Staff for use of their cell phones in the conduct of Legislative business. Thus, as of 2013-2014 this measure has ensured that there is no longer a cost to the legislature in regards to the provisions of cell phones and their usage at the Legislature.

Special Note: In 2014 the estimated cost of new car insurance will increase slightly slightly because of "Comprehensive Coverage as of 2014" but will be offset by lower fuel and maintenance expenses due to more efficient engines and new car maintenance warranties



Senate President Shawn-Michael Malone was elected to his sixth legislative term on November 6, 2012. He was born August 29, 1968 and raised on St. Thomas, US Virgin Islands. Senator Malone is the fifth of six children born to the late Roy Milton Malone, a noted Virgin Islands musician and Pauline Monell-Francis Williams. He attended Dober and E. Benjamin Oliver Elementary schools, Bertha C. Boschulte Junior High School and Ivanna Eudora Kean High School and graduated from Sts. Peter & Paul High School in 1986.

Senator Malone obtained his Bachelor of Arts in Political Science from Hampton University in Hampton, Virginia in 1991. Prior to his 2002 election to the 25th Legislature, his private sector work included management and auditing duties with the Ritz-Carlton, St. Thomas, the Marriott Frenchman's Reef Resort, and the Michael A. Simmonds Company. Senator Malone worked with the Federal Emergency Management Agency (FEMA) and later as District Manager for Virgin Islands' Congressional Delegate Donna M. Christensen. He was Aide to former Virgin Islands First Lady Joan Harrigan-Farrelly in the V.I. Department of Planning and Natural Resources. He was also Chairman of the St. Thomas-St. John Board of Elections and Vice Chairman of the Virgin Islands Joint Boards of Elections. Upon becoming a senator, he has chaired five major committees and has held every officer position in the Legislature.

The Council of State Governments (CSG) bestowed on the Senator their prestigious Toll Fellow designation in 2006. He maintains a professional affiliation with CSG, the National Conference of State Legislators (NCSL) and the National Black Caucus of State Legislators (NBCSL). He became a member of the Executive Committee of the NCSL in December 2012. He was then re-elected as the

Vice Chairman of the 12th District for the NBCSL, part of the organization's Executive Committee.

The Senator's numerous legislative achievements include sponsoring the Virgin Islands Smoke Free Act, and changing local laws to increase the number of senators needed to approve Coastal Zone Management permits. Senator Malone has also focused on education and is the founder of the Reading to Achieve learning program, offering incentives for students to improve their reading and communication skills. He is committed to promoting Virgin Islands culture, and legislated Quelbe as the official music of the Virgin Islands; designating March as Virgin Islands History Month, and the establishment of the 5th Constitutional Convention.

He founded the St. Thomas Heritage Dancers and his contributions to Virgin Islands Carnivals resulted in his selection as the Grand Marshal of the 2009 Adult's Parade. He serves on the Board of Directors for the Miss America Virgin Islands Scholarship Organization and Sts. Peter & Paul School, is a member of the Knights of Columbus and holds active membership in Omega Psi Phi Fraternity. His dedication to coaching young athletes resulted in his induction into the National Baton Twirling Association (NBTA) Hall of Fame in 2005.

Consistent with the political activism of his late Great Grandmother Rosa Barthlett, who was a founding member of the Virgin Islands Democratic Party, Senator Malone, a lifelong Democrat, has served as President of the Young Democrats of St. Thomas-St. John (1994-96), and with the National College Democrats organization (1988-90), and was an elected Delegate to the 1996, 2000 and 2008 Democratic National Conventions...

Consequently, his community involvement has been extensive including the following: service on the Boards of the St. John Community Foundation, the Environmental Association of St. Thomas-St. John (EAST), the League of Women Voters, the Interfaith Coalition and the St. John Singers. He has

been an active and an honorary member of the Rotary Club of St. John. He is also a member of the Territorial Committee of the Virgin Islands Democratic Party and was a member of the Virgin Islands Girl Scout nominating committee. He has even served as a volunteer in the park, counting sea turtle nests on St. John.

Since taking up residency in the territory, Senator Barshinger has worked towards the progress of the Virgin Islands. Senator Judi Buckley was born in Warsaw, Indiana but moved to Alabama, her parents' home state, at the tender age of two months. Her parents, Pastor Wade and Pat Johnson, were missionaries and felt called to the Caribbean. In 1974 when Judi was only eight years old, they packed her and her three sisters up and moved the family to St. Maarten. After starting a church and serving the community for four years, they moved to Minnesota for the next four years – then were called back to the islands. This time they felt led to the island of St. Croix. So in 1982 St. Croix became home. Judi's parents started St. Croix Community Fellowship and remained on island for 12 years.

Judi graduated from Limetree Academy (former Cruzana Manor, current AZ Academy location) on St. Croix. In 1983 Judi was crowned Miss Limetree Academy, and in 1984 she won the Miss VI National Teenager title. Senator Clifford F. Graham was born on St. Thomas, U. S. Virgin Islands on October 7, 1965 to Irene Graham and the late Charles E. Graham. He attended the James Madison and E. Benjamin Oliver Elementary schools, the Berta C. Boschulte Junior High School, and is a 1983 graduate of the Ivanna Eudora Kean High School. Clifford's education continued, first at the College of the Virgin Islands then at Hampton University, Hampton VA, where in 1989 he earned a Bachelor of Science degree in Building Construction Technology.

Upon graduation, Senator Graham accepted a job in construction management with Walbridge Aldinger, in Detroit, Michigan. In 1991, was recruited back to the Virgin Islands by the Virgin Islands Department of Planning and Natural Resources to work in the Building Permits Division. After an exemplary work performance, Clifford was selected as the 1993 Department of Planning & Natural Resources' Employee of the Year. In 1994, Clifford transferred to the Virgin Islands Housing Finance Authority and worked in their Planning and Construction Division. In 1995, he was again selected for his exemplary work performance and represented the Virgin Islands Housing Finance Authority as their Employee of the Year. In 1996, Senator Graham was promoted to the Director of Planning and Construction, where he was responsible for all of the Authority's Affordable Housing planning and development throughout the Territory.

On July 30, 2001, after the retirement of the Virgin Islands Housing Finance Authority's Executive Director, Senator

Graham was selected by the Board of Directors to serve as the Interim Executive Director. He served as Interim Executive Director for a year, and in July 2002 the Board of Directors selected him to serve as the Authority's 5th Executive Director, a position he held until April 18, 2011. As Executive Director, Senator Graham spearheaded a plan for the Authority to erase several years of budget deficits and to complete its own mission of achieving ownership by moving from rental office space into their own building in 2006. The outstanding accomplishments and strong leadership at the Virgin Islands Housing Finance Authority, resulted in the Government of the Virgin Islands implementation of a plan which in the troubled Community Development Block Grant and the Emergency Housing programs were merged into the Authority in 2008. Immediately thereafter, Clifford led the task of transforming the dilapidated housing stock of the former Emergency Housing into new affordable housing communities.

Senator Graham was elected to the 30th legislature where he serves as chairman of the Finance Committee. Senator Graham has maintained a strong commitment to his community by volunteering, as a Board Member of My Brother's Workshop and as the Board Treasurer of the St. Thomas Federal Credit Union. Senator Graham has been married for over 15 years to Arlene Athill from St. Croix and is the loving father of two boys; Omari and Ahmad.

Senator Alicia Hansen, was born to Martin Pickering and Medora Paulis Williams. She graduated from the Jose C. Barbosa High School and attended the Inter-American University (both in Puerto Rico). Senator Hansen went on to attend the Virgin Islands Police Academy and the University of the Virgin Islands where she received training in criminal law and paralegal studies.

Prior to her first elected term to the 17th Legislature in 1986, Senator Hansen worked as a legal researcher and translator for the Attorney General's Office, and Counselor at the Department of Human Services. She was proprietor of the Strong Foundation Institute for Learning, an early childhood educational program, and was a High School Spanish teacher at the Limetree Academy on St. Croix. She was also the proprietor of Chucky's Boutique. In the 18th & 19th Legislatures, Senator Hansen was Secretary of Inter- Governmental Relations and Territorial Affairs. During her term in the 20th Legislature, she served on the Education, Health and Housing, Parks & Recreation Committees. In the 21st Legislature, Senator Hansen chaired the powerful Finance Committee. She also served as Vice Chair of the Committee on Housing, Parks & Recreation and was a member of the Committees on Rules, Economic Development, Agriculture & Consumer Protection and Planning & Environmental protection. In the 22nd Legislature, Senator Hansen served as Chair of the Committee on Labor & Veterans Affairs and was a member on the Economic Development, Agriculture and Consumer Protection and Planning and Environmental Protection Committees.

In 1998, in her seventh election, Senator Hansen garnered the highest number of votes for the fifth time. Her success has distinguished her as one of the most popular politicians historically in the district of St. Croix and perhaps the entire Virgin Islands. Senator Hansen holds the record on the highest number of votes any senator

has ever received in the district of St. Croix thus far. She chaired the powerful Finance Committee twice, once in the 21st Legislature and again in the 24th Legislature. She delivered four fiscal year budgets on time, with new revenue generating measures and without further taxing the people of the Virgin Islands. At the conclusion of her eighth term in office, Chucky Hansen retired for eight years; but after serious consideration, she decided to respond to the call of the people and returned to the political scene. Senator Myron D. Jackson The son of Mrs. Bernice Peterson Jackson, retired Community Health Nurse, and the late Hugo D. Jackson, Businessman and Community Activist, Senator Myron D. Jackson was raised in Hospital Ground, in the historic "Upstreet" Neighborhood of St Thomas. His 32 years of public service personify the African proverb "Go back and fetch it," and the saying has been his guiding principle in his life long before he formally knew of it. As a young teen, for example, he made a name for himself when he and fellow students mounted a public campaign to preserve the architectural integrity of the historic blue bit stone sidewalks in the Charlotte Amalie Historic District in opposition to the Virgin Islands Government plans to cement them. A graduate of CAHS High School in 1975 and the Parsons School of Design in New York, Jackson became a preservation activist early in life and has remained active in cultural, civic and preservation organizations and in government, dedicating his life's work to the protection of the cultural resources and heritage of the Territory. Following his graduation from Parsons, Jackson returned to the VI and joined the Department of Conservation and Cultural Affairs and was recruited to the Planning Office which later became the Department of Planning and Natural Resources. He has served in a variety of capacities including Graphic Artist, Senior Planner, Cultural Advisor to Governor Alexander A. Farrelly, Director of the Virgin Islands State Historic Preservation Office and the Executive Director of the Virgin Islands Cultural Heritage Institute.

In addition to his professional service, Jackson is a member of various civic cultural organizations, including the following: President, We From Upstreet, Inc.; President, Virgin Islands Genealogical Society; Caribbean Genealogical Library; The Traditional Indians and Jesters Carnival Troupes; St. Thomas Historic Trust, St. Croix Landmark Society; Save Magens Bay and The Save Long Bay Coalitions. Jackson has published in the area of cultural preservation and has produced and/or participated in TV and radio programs which celebrate VI history and culture. His human interest has led him to travel and conduct cultural research and investigations in the Caribbean, Africa, Europe, South America and Asia.

Senator Jackson's involvement in politics has been in response to the enthusiastic encouragement by the public. He was elected Delegate to the VI Fifth Constitutional Convention and ran for the position of Senator for the 28th Legislature. Although he lost that election, he was strongly encouraged by the experience and ran again for a position in the 30th Legislature which he won with an overwhelming response from voters. Senator Tregenza A Roach is a proud graduate of the Charlotte Amalie High School. He attended the then College of the Virgin Islands for two years, before transferring to the University of Missouri-Columbia, where he earned a Bachelor of Journalism in 1981. Roach subsequently enrolled at the University of Connecticut School of Law, where he obtained his juris doctorate in 1989. He has been a member of the Virgin Islands Bar since 1991.

Senator Tregenza A Roach has called St. Thomas home since 1968, having migrated here from his native St. Kitts with his parents, Victor and Iona Roach. He brings a wealth of experience in the areas of journalism, law, and education. Upon completion of his journalism degree, he returned to St. Thomas to work at the Daily News of the Virgin Islands. He spent five years with the company, serving as News Editor for the final three years of his employment. While attending law school, he gained valuable legal experience, clerking first in the Office of the Governor's Legal Counsel, then the Office of the United States Attorney, and finally at the Territorial Court of the Virgin Islands. After earning his law degree, he worked in the Territorial Court's Civil and Family Divisions and then in private practice as an Associate Attorney at Bornn Bornn Handy and Rashid.

Senator Tregenza A Roach, then began his public service with his employment at the Department of Education as Legal Counsel to the Commissioner, a position he held for more than eight years. During his tenure at the Department of Education, he worked closely with a total of six individuals who held the position of Commissioner or Acting Commissioner. Some highlights of his role as Legal Counsel include: functioned as primary legal advisor to the Commissioner of Education regarding the application of all local and federal statutes, provided counsel and guidance with regard to labor, contract and student matters, and coordinated the Department's negotiating team, developing bargaining positions and strategies in conjunction with the Office of Collective Bargaining.

Ending his tenure with the Department of Education, Attorney Roach was selected as Executive Director of the Virgin Islands Board of Education, a position which afford-

Although the University project ended in 2008, the United Nations qualified Roach as an expert on the subject of constitutional development processes in the U.S. Territories and invited him on his own merits to a third Decolonization Seminar in Basseterre, St. Kitts in 2009.

He recently published his first book for children, The Lesson Box, which joins his other publications, The Blessing of Rain and Other Poems, and All This Is Love, A Collection of Virgin Islands Poetry, Art and Prose. He was awarded the Margaret Walker Fiction Prize by the Detroit Writers Guild in 1999 and was chosen by the St. Thomas/St. John Library Association for its Distinguished Caribbean Author Award in 2009.

Sen. Janette Millin Young is a 1987 graduate of Sts. Peter and Paul High School on St. Thomas, Virgin Islands. She earned a Bachelor of Arts degree in Broadcast Journalism, with a minor in Sociology from Loyola University in New Orleans, Louisiana in 1991. Sen. Millin Young has exhibited high qualities of leadership since high school. Upon graduating from high school, she received her Class' Leadership Award and carried the qualities that earned her this distinction on to college.

At Loyola University in New Orleans, Sen. Millin Young represented her school, along with a handful of other students at a Youth Leadership Conference in Atlanta in 1991. Section V

Standard Operating Procedures & Professional Development

Brief Summary: The following section briefly presents the various policies, procedures, and professional developmental training implemented and or conducted at the 30th Legislature of the Virgin Islands.

Standard Operating Procedures Utilized for all Legislature's moving forward

TRAVEL

All Inter-Island travel (including Puerto Rico) for the conduct of Legislative business shall be requested by a Senator or Division Head through the Executive Director on the forms created for that purpose. All travel away from the Territory shall be requested to the President on forms provided for that purpose. The business to be conducted by the Senator, Senatorial Staff or Central Staff Employee shall be briefly explained in the space provided on the forms, and the forms shall be signed by the requesting Senator or Division Head.

The cost of all travel outside the Territory, including Puerto Rico, or between the Districts, including St. John, shall be attributed to the respective Senator's allotment, or the allotment of the Committee to which the Senator or Staff member is travelling, or the expense may be assessed against the Legislature's operating account, as may be authorized by the President.

PER DIEM

For the purpose of compensating Senators and Staff for travel related expenses, Per Diem of thirty dollars (\$30.00) shall be paid to Senators, for "same-day" inter-island travel or same-day travel to and from Puerto Rico.

Inter-District business travel by Senators and staff which require overnight stays on the Island which is not the Senators' or staffs' home Island (including Puerto Rico) are eligible for compensation of seventy five dollars (\$75.00) per night and related airfare and paid hotel accommodations. The hotel accommodations shall be secured by the delivery of an authorization letter or business check to hotels approved by the Legislature, authorizing the Senator's or staff's stay for the requested period of time. The hotel stay authorization letter shall specify that only the room charge and applicable taxes are authorized to be incurred by the Senator or staff on the Legislature's account. In-room dining and in-room land-line telephone calls shall not be charged on the Legislature's account.

Travel away from the Territory by Senators, their Staff or Central Staff employees shall be applied for in advance and may be approved by the President, in his discretion. Such travel shall be for conferences, meetings or events specifically related to the business of the Legislature.

Senators and Senatorial staff travel shall be arranged by the Senator's staff after approval has been secured from the President. Central staff travel out of the Territory shall be approved by the President in his discretion and arranged by the respective Division Heads through the Executive Director.

Hotel accommodations for Senators and all Staff shall be paid by bank check drawn on the accounts of the Legislature and debited from the affected Senator's allotment, the appropriate Committee allotment, or the Legislature's operating account, as appropriate. In the event the hotel or resort advises the traveller in advance that a Legislature's bank check is not acceptable, the traveller may be provided a Legislature bank check made payable to the traveller. The traveller shall then deposit same to his or her bank account and utilize the deposited funds to defray the hotel expenses.

In the event the Senator or staff's travel is to attend a pre-announced conference, meeting, or event wherein "early bird" registration fees, airline tickets and discounted hotel room prices are offered, the Senator or staff shall receive a Legislative bank check for the discounted hotel and event registration fees only. Should the Senator or staff not avail themselves of the discounted hotel room prices or registration fees, the additional cost, if any, for hotel rooms and registration fees shall in each case be borne by the Senator or staff member. Should the Senator or staff member also fail to secure early bird airline tickets, they may also be required to bear all or a part of the additional costs therefor, in the sole discretion of the President. Airfare expenses for travel out of the Territory shall be based on "coach" fare and shall utilize the most direct and economical air travel to and from the Senator's or staff member's home island. Senators and Staff who deviate from the direct "home-to-conference-to-home" routing shall bear the cost of such deviations from their own personal resources. Per Diem for business travel out of the Territory, excluding Puerto Rico, by Senators and all Staff shall be based on Seventy-Five Dollars (\$75.00) per day-or any portion thereof, per trip.

In the event Senators or Staff are invited to ceremonial or special activities in their official capacities away from their home Districts, and overnight accommodations are required, the Senators or Staff shall, after written approval by the President, receive airfare, the \$60.00 Per Diem and hotel room authorization for only one (1) night away from their home Island.

Reimbursement of authorized Per Diem for overnight, inter-island travel shall be computed and paid every three (3) months. Reimbursement of authorized Per Diem for off-island travel shall be computed and paid within twenty (20) days after receipt of proper and accurate documentation of the associated travel.

TRAVEL EXPENSE REPORT

All Senators and Staff shall utilize the interactive Travel Expense Report for the purpose of reporting on the expenses incurred during official business trips and for reimbursement, if appropriate. All airline boarding passes as well as any other evidence of the traveller's attendance at the meeting, conference or function shall be appended to the traveller's Travel Expense Report.

MANAGEMENT, USE AND OPERATION OF LEGISLATIVE VEHICLES

The following Standard Operating Procedure (SOP) for the management, use and operation of the Legislatures vehicles shall be as follows and apply on St. Croix, St. John and St. Thomas:

- All Legislature passenger vehicles and trucks shall be operated only by employees and Senators of the Legislature who are properly licensed, skilled, and covered under the Legislature's Auto Insurance Policy.
- All vehicles and trucks shall be operated during the workday only, and all vehicles shall be returned to the Legislative buildings and parked in their usual spaces at the close of each business day.
- 3. No employee, including Directors, Assistant Directors and the St. John Annex Staff shall be permitted to operate at Legislature vehicle or truck on weekends, holidays or overnights, except as set forth herein.
- 4. In the event a Senator requires and requests after-hours transportation services (after 5:00 on week-days or on weekends or holidays) the Senator may secure one (1) of the Legislature's passenger vehicles for him or her to personally operate by signing out the vehicle through the Director of Transportation (or St. John Annex Administrator) on the respective islands. The subject Sign Out Log shall indicate to which Senator the vehicle was released; whether the Senator was to be chauffeured or self-operate the vehicle, and the out-in mileage.
- 5. In the event a Senator is to be chauffeured after the regular close o business in one of the Legislature's vehicles by an employee of the Legislature, the operator of said vehicle shall pick up the vehicle from the Legislature's Compound before picking up the Senator, and shall return the vehicle to the Compound immediately after transporting the Senator to his or her destination; except as specifically set forth herein below.

6. When a Senator or staff of the Legislature is to be transported in a Legislature vehicle to an off-site meeting or activity, the driver of the subject vehicle shall remain at the site for not longer than fifteen (15) minutes (20 minutes in the case of St. Croix), after which the vehicle operator shall return the vehicle to the Legislature's Compound for re-assignment or to await being summoned to retrieve the Senator or staff from the site where he or she was last discharged.

PROHIBITION AGAINST GUNS IN THE LEGIS-LATURE WORKPLACE

An unacceptable risk of harm to Senators, employees and visitors to Legislative facilities is posed by the possession of guns on the properties and facilities owned, operated or managed by the Legislature of the Virgin Islands; and,

WHEREAS, the Attorney General of the Virgin Islands, in an official Opinion of The Attorney General dated January 16, 2014, determined that while employees of a department or an agency may lawfully be authorized to carry a firearm while at work pursuant to 23 V.I.C. Subsection 454 et seq., the head of a department or agency may "promulgate rules which pertain to possession of weapons in the workplace, and therein require that employees or visitors who are licensed to carry concealed weapons, check those weapons at the door."

It is the policy and operating procedures of the Virgin Islands Legislature that all employees of the Legislature who own, possess, or come into possession of a firearm shall not carry such a firearm, firearms, or weapons in places designated as the Legislative job sites, nor in vehicles owned or operated by the Legislature.

Legislature personnel shall not carry or possess guns at any time during their work hours or when they are otherwise acting in official capacities on behalf of the Legislature.

This policy and procedure shall not apply to Legislative employees or visitors who have been designated as "peace officers" by operation of law.

Appropriate notice of the operating procedure banning firearms from Legislature facilities and workplaces shall be prominently posted and displayed in areas on or about Legislative facilities and workplaces; including Legislative vehicles.

CELL PHONE ACQUISITION AND USAGE

The Legislature shall not provide cell phone devices to Senators nor Staff, and shall not compensate or reimburse Senators nor Staff for use of their cell phones in the conduct of Legislative business. Professional Development Human Resources Employee Manual

The 30th Legislature of the Virgin Islands has drafted and implemented a "Human Resources Employee Manual." The Manual is "user friendly," clearly defining the regulations, policies and procedures that each employee of the Virgin Islands Legislature; Central Staff and Senatorial Staff is expected to adhere to. It is for this reason that each employee was required to acknowledge the receipt of the Manual via an enclosed attachment. The rules, regulations, policies and procedures that comprise the document pertain to individual, professional and personal behavior while in the Legislature's work environment. Every employee is bound by the regulations, policies and procedures contained in the Manual. Therefore, each employee will be required to meet the standards and criteria specified in each section as members of the Legislature's staff. As a member of the Staff of the Virgin Islands Legislature, it is anticipated that by adhering to the rules and regulations, each employee shall enjoy a productive working environment.


The Legislature of the Virgin Islands adheres to the Constitutional rights of all persons, and recognizes the right of equal employment opportunity without regard to race, creed, color, sex, sexual orientation, disability, marital status, religion or national origin. It is the Legislature's policy that all employees of the Legislature must be able to enjoy a work environment free from all forms of prohibited discrimination, including sexual harassment, retaliation and an otherwise hostile environment. It is also the Legislature's requirement that employees treat one another with utmost respect.

The Legislature promotes a work environment free of sexual harassment. Sexual harassment, retaliation and the creation of a hostile environment are specifically prohibited as unlawful and constitute a violation of the Policy Manual. The Legislature is committed to efforts for preventing sexual harassment in the workplace, for taking immediate corrective action to stop sexual harassment in the workplace, and for promptly investigating and resolving any allegations of work related sexual harassment complaints.

Senator Lorraine L. Berry Building Ceremony

Members of the 30th Legislature joined family, friends, and colleagues of the late Lorraine Ledee Berry at the Earl B. Ottley Legislative Hall for the naming of the Legal Counsel building in observance of the former senator's service.

"Consistent, visionary, steadfast, forthright, courageous, judicious, dedicated, determined, intelligent, inquisitive, politician, loving wife, daughter, mother and proud Virgin Islander," said Senator Malone.

Act 7324, sponsored by Senators Janette Millin Young and Shawn Michael Malone, was created to commend Sen. Berry for her years of public service and to name the legislative complex containing the Legal Counsel and other offices in her honor.

"As I developed the resolution to honor her, I thought what better place to name after this awesome legislator than the building that houses our legal counsel division. It is the place where measures are drafted for inclusion

in our very important V.I. Code. And Sen. Berry, after 12 consecutive terms in office, contributed hundreds of bills to our V.I. Code. And so therefore, her name will live in perpetuity," said Senator Millin Young.

The recurring sentiment among those who spoke—family, former employees and friends—was Senator Berry's firm commitment to always act in the best interest of the people of the Virgin Islands.

Richard Berry, husband to the late senator shared that two mentors, former governors Cyril E. King and Earl B. Ottley, were especially responsible for the launch of his wife's political career. Both commended her for her ability to be aggressive and courageous when speaking about a variety of concerns—from her children's primary school education to the grander issues affecting the territory—and suggested she run for the senate.

One of the first pieces of legislation she drafted, along with then Sen. Iver Stridiron, regarded the territory's



conversion to the electronic voting system, ending the sleepless nights of counting ballots and the seemingly endless and misleading fluctuating results. Berry also sponsored the legislation that established the donated leave program, assisting families in their time of need. The program allows government employees to donate sick leave to other employees whose accrued sick leave would expire before they are able to return to work. The legislation has been helpful to many of those who suffer from medical challenges.

Sen. Berry died on July 19, 2010 after a year-long battle with colon cancer. She is the only member of the VI Legislature to serve 12 consecutive terms. During her tenure as a public servant, she chaired eight committees, served as a majority leader, and sat as the senate president twice—the second of only two women in Virgin Islands history to have served as president.

Black History Month

Black History Month Reception - The Legislature had had the privilege to discuss potential minimum wage increases and other issues with Obama Administration officials and members of Congress at Vice President Joe Biden's Third Annual Black History Month reception at Biden's official residence at the U.S. Naval Observatory which included Charles Rangel, representative from New York's 13th Congressional District.

More than 140 guests were in attendance, including Attorney General Eric Holder, U.S. Trade Representative Ron Kirk, and EPA Administrator Lisa Jackson, as well as members of the Congressional Black Caucus, the National Black Caucus of State Legislators, the National Conference of Black Mayors and the National Organization of Black County Officials. Senator Malone serves on the Executive Committee of the National Black Caucus of State Legislators.



Legislative Summer Internship Program

The Legislatures' Summer Internship Program gives students mostly within the territory an opportunity to learn more about various aspects of politics and public administration. The program normally includes enrichment activities pertaining to parliamentary procedure; legislative research and archival processes; post-audit analysis; management information systems; public affairs; bill drafting; and legal analysis. The program is funded by the legislature and is operational when funds are appropriated and released during the fiscal year.



Nelson Mandela Ceremony

Members of the 30th Legislature, honored and remembered the late President Nelson Mandela during "A Tribute to Anti-Apartheid Revolutionary & Civil Rights Activist" Ceremony, held at the Earle B. Ottley Legislative Hall.

The ceremony included remarks from Senator Myron Jackson, who shared a brief synopsis of the life of Mandela and his fight to stop the government-sanctioned system of apartheid in South Africa.

Several Senators and Senate President Shawn-Michael Malone honored Mandela during a memorial service held at the Mandela Circle and Edward Wilmoth Blyden Drive; which now features a large billboard featuring a picture of Mandela that is accessorized with flowers, purple and black ribbons.

The ceremony continued with additional senatorial remarks, a message from Keynote Speaker Judith Bourne, poetry read by the students from Charlotte Amalie High School and Bertha C. Boschulte Middle School, drumming

performed by Keith Brown and Feba Reid. The Shaka Zulu Troupe preformed a dance, and Heru Ofori-Atta performed spoken word. Nelson Mandela was born on July 18, 1918 on the banks of the Mbashe River. His original name was Rolihlahla. Eventually, he was given the name Nelson by a white teacher. Mandela devoted his life fighting against apartheid.

After years of combating apartheid, Mandela was sentenced to life in prison. However, after serving 27 years due to an international outcry he was released in 1990 and was awarded the Nobel Peace Prize three years later. By 1994, he was the first black man to be elected President of South Africa. The Mandela Administration focused on reconciliation, a new constitution and the expansion of the healthcare program. In his later years, he served as an elder statesman who fought against poverty and HIV/Aids prevention through the Nelson Mandela Foundation. At the age of 95, Nelson Mandela passed away on Thursday, December 5, 2013.

Legislative Youth Advisory Council – (LYAC)

CHARLOTTE AMALIE-ST.THOMAS—The territory's first Legislative Youth Advisory Council conducted its swearing-in ceremony at the Earle B. Ottley Legislative Hall on Monday, December 16, 2013.

The council, which consists of 16 members of the territory's youth, is a product of Bill No 29-0102 proposed in the 29th Legislature by Sen. Terrence "Positive" Nelson and Nereida Rivera O'Reilly now known as ACT NO. 7303. The council will act as a liaison between the community and the legis-

lature to provide input on proposed and pending legislation, budget expenditures and policy related to youth in the community. Senate President Shawn-Michael Malone congratulated chosen students for their accomplishment of making it through the selection process. "This is a special day for us and for the entire Virgin Islands," said Sen. Malone.

Sen. Malone quoted Franklin D. Roosevelt who said, "We cannot always build the future for our youth, but we can build our youth for the future." He also



added that he would like to see a bill passed during the remainder of the 30th Legislature with the input of the Youth Advisory Council. Sen. Nelson noted that it was no coincidence that President Nelson Madiba Mandela was laid to rest the day before the swearing in ceremony. "It's your turn," he told the council. "You may not have all the answers, but it's your turn regardless. Do not be afraid."

Shaulia Todman, chairperson of the Youth Ad-



visory Council spoke on behalf of the youth in the territory. "I hope that it isn't easy for policy makers and other decision makers to ignore the ideas offered by the next generation who stand to inherit so many unsolved problems of the world," she said. "We are the next generation and we are concerned."

The Honorable Chief Judge Michael C. Dunston of the Virgin Islands Superior Court, who sat on the selection committee, challenged the new council to be the change. "Use this as an opportunity to assist those who do not have your accomplishments, who do not have your impressive resumes, who do not have your skills and talents," he said. "Find a way through this counsel to assist those who are about to drop out of school, who are about to join a gang, who are about to turn to violence, who are about to turn to drugs because with your vision this legislature can do something to help solve those problems in the Virgin Islands."

Donna Frett-Gregory, Commissioner of the Department of Education congratulated the council, saying that she was overwhelmed. "Young people, you are going to change the face of this territory," she said.

Sen. Judi Fricks-Buckley shared a piece of advice to council members after offering congratulations. "Don't be afraid to tell us the truth," she said. The 16 members of the council include: Deja Adams, Areannah Agathe, Amiel Brown, Clemrick Bryan, Anumaat Davis Kahina, Kevin Dixon, Cyana Francis-Berkitt, Yohance Henley, Bria James, Zion James, Ke'Shawn Louis, Owen Sanford, Jordan Thomas, Gleason Thompson Jr. Shaulia Todman, and Raeniqua K. Victorine



Investing in our future

Senate President signs MOU for \$1 million alternative energy study

Low cost electricity, plentiful potable water for drinking and farming, aquaculture, new industries spurred on by affordable power, fixed energy costs, electric cars and reduced pollution are among the potential positive outcomes if the U.S. Virgin Islands implements Ocean Thermal Energy Conversion Technology (OTEC) - an innovative, alternative energy system that generates power via the differential between warm surface and cold deep sea temperatures.

On behalf of the 30th Legislature, Senate President Shawn-Michael Malone signed off on a Memorandum of Understanding with the Ocean Thermal Energy Corporation for it to conduct a study to evaluate the feasibility of installing OTEC renewable energy power plants and Seawater Air Conditioning (SWAC) facilities in the United States Virgin Islands.

This MOU is one result of the V.I. Renewable & Alternative Energy Act of 2009 and its drafting was authorized last year via Resolution 1795.

Senator Craig Barshinger, Chairman of the Committee on Energy & Environmental Protection, joined the Senate President at the signing of the MOU. Senator Barshinger was the primary sponsor of Resolution 1795. Senator Malone urged Ocean Thermal Energy Corporation representatives to hire locals to facilitate the study and thanked them for investing their time and money in the Virgin Islands. "We're very pleased to have this opportunity today to follow through on what the Senate has acted upon," Senator Malone said. "Through the signing of the MOU we are demonstrating this Body's accountability as it relates to bringing long term solutions for solving our energy crisis."



Six-Pack Rule Advances in Congress

Senate President Shawn-Michael Malone praised the United States House of Representatives for passing a law that exempts Virgin Islands charter boats from the six-passenger limit restriction. When the new regulations were implemented most of the charter yacht industry left the territory in favor of operating out of the less restrictive British Virgin Islands. The Bill now faces a vote in the U.S. Senate.

The proposed legislation came as a result of the collective efforts of many to include the Office of V.I. Delegate to Congress Donna Christensen and the Congressional Outreach Program, which Senator Malone first initiated working in conjunction with former Governor Charles W. Turnbull. The program, later adopted and continued by the de Jongh Administration, brings congressional leaders to the territory to familiarize them with issues critical to the Virgin Islands.

Pennsylvania Congressman Bill Shuster, Chairman of the House Transportation Committee, who introduced the bill, was here as part of the outreach program in November of 2013. Senator Malone added that in recent months West Virginia Senator Jay Rockefeller had committed to advance a senate version of the six-pack exemption measure.





Legislative Report Additional Disclosure

In addition to the listed developments in the territory, we take this time to note that a major development for the territory's Financial Industry is reflected in Act No. 7390 Bill No. 29-0308 which Amends Title 9 Virgin Islands Code, adding chapter 25, "The International Banking Center Regulatory Act," and repealing chapter 21 of title 9 which the current members of the 30th Legislature acknowledges and agrees to take immediate action on this major piece of legislation in the near future." "I wanted a complete update on this case as well as information about the recent symposium Harvard University held focused on this issue," Senator Malone said. "If American Samoa prevails it could lay the groundwork for increased benefits for us all to include expanded voting power for our Delegate to Congress and a vote in Presidential elections."

Recently the NBCSL agreed to support Senator Malone's resolutions calling for enhanced rights for Virgin Islands residents to include participation in Presidential elections, expanded voting rights in Congress and greater federal protection for Virgin Islands borders.

Senate President Malone works with national organizations to lobby on behalf of the U.S. Virgin Islands, Conference call with President Obama

CHARLOTTE AMALIE, U.S. VIRGIN ISLANDS - Senate President Shawn-Michael Malone, recently tapped to serve on the Executive Committee of the National Conference of State Legislatures, is meeting with the organization's leaders this week in Austin, Texas. The NCSL is the premier organization representing state Governments at the national level and provides various resourc-

es to state legislature

Senator Malone was elected to the post last fall by a committee of legislators from more than a dozen states. He is the first and only official from a United States territory to serve on NCSL's Executive Committee.

"We work with each other to lobby the federal government on various issues and to gain insights as to what laws or policies have had a positive impact in our jurisdictions," Senator Malone said. "My focus is to make the states more aware of the need for all U.S. citizens to be treated equally".

He is also a member of the National Black Caucus of State Legislators and was invited to participate in a teleconference today with President Barak Obama in order for the Chief Executive to highlight pieces of his State of the Union address and discuss ways in which lawmakers can help to support key policies in their states and territories. "I found President Obama's State of the Union speech to be very uplifting for the most part and I was struck by our mutual concern that we are not adequately preparing our young people for the jobs actually available today," the Senate President said. "I also agree we have a serious problem with the widening income equality gap - something that is perhaps being felt even more acutely here in the territory than the rest of America. Much of

Obama's vision will depend on the President having willing partners in state legislatures and I do support an eventual increase to our local minimum wage, though the timing is something we have to carefully consider given the economic climate. What was missing for me in his speech was any specific reference to greater inclusion of United States territories - I contend we are equally American and entitled to the same health care and other benefits and must be given the rights to a real voice in Presidential elections and Congress. We are approaching our 100th Anniversary as an American territory and it is time that we relinquish our second-class citizen status. Given the chance, it is my hope to convey this to the President."

As an Executive Member of the NBSCL, Senator Malone recently had an opportunity to introduce three resolutions that the group adopted on behalf of the U.S. Virgin Islands.

The resolutions include increased funding for Virgin Islands border protection in order to help stop the flow of weapons, guns and illegal immigration; the restoration of voting rights to the Virgin Islands Delegate to Congress; and the right for Virgin Islanders to participate in presidential elections. Later this year Senator Malone will introduce a resolution to calling for the territory's full inclusion in the Affordable Health Care Act.

In addition to providing training and resources, the NBCSL's primary mission is to serve as a strong, united and effective advocate for African American state legislators and their constituencies at the federal level.

Senate President meets with Royal Danish Consulate General

CHARLOTTE AMALIE, U.S. VIRGIN ISLANDS - Senate President Shawn-Michael Malone had what he and Denmark's Consul General each described as a "brainstorming session" as to the role that nation could play in the economic development of the Virgin Islands and in the upcoming centennial recognition of the territory's transfer from Denmark to the United States.Ambassador and Consul General of Denmark in New York, Jarl Frijs-Madsen, was in the Virgin Islands this week for Transfer Day ceremonies.

"Denmark has provided us with a steady stream of tourists for many years, but I would like to expand on this and look towards Danish investment in this industry, particularly on St. Croix," Senator Malone said. "I shared the details of our Hotel Development Act and the other incentives available to potential investors." Senator Malone said that Denmark continued to be among the world's leaders in renewable and clean energy projects and that he would like to find a

way to utilize that country's expertise and experience in this area to assist the territory in reducing its dependence on fossil fuels and lowering energy costs. "I would like to see us foster greater cultural and educational exchanges in general," Senator Malone said. "Though our relationship with Denmark as a former colonial power is complex, we can't deny its existence nor the fact that we are bound by our shared history and even familial ties."

The Senate President and Consul General Frijs-Madsen also discussed Denmark's participation in the Transfer Centennial programs planned for 2017.

"We would like to find a way to engage both Virgin Islands and Danish youth in this regard," Senator Malone said. "We will be speaking again on this issue."

The Senate President thanked the Danish Consul General for visiting the territory and the Legislature.
